ABOUT THE FACILITY

Governed by an 11-member primarily appointed County Board, Daviess Community Hospital with 73-staffed beds offers a full array of acute care services, an inpatient rehab unit, and a Gero-psych inpatient unit. It offers a full array of outpatient services for the area plus home care, hospice and home infusion.

Primary service area is estimated at 32,000; total service area at 52,000. There are 26 physicians on active staff, plus 72 consulting physicians. The hospital's ADC is 34; Gross revenues are \$90M; Net revenues are \$45M; A/R days = 53 (gross); Bad debt = 3.3%; Days cash on hand = 53.

The Gero-psych unit was recently expanded from 14 to 20 beds; PACs was implemented in 2006. The new Health Pavilion (includes urgent care center and medical clinic) opened in May 2008. The facility also owns and operates medical clinics in Washington, including a walk-in Quick Care Clinic that opened in 2008.
